2. Earnest Money Deposit: An EMD of Rs. 5,000/- (Rupees Five Thousand only) should be deposited along with the bid in the form of an account payee bank draft/pay order of a nationalized bank favouring SANSKRITI SCHOOL, New Delhi payable at New Delhi.

The Earnest Money Deposit (EMD) of the successful tenderer shall be adjusted in the bid amount. The EMD of the unsuccessful tenderers shall be returned within one month after tender opening date, without any interest.

The EMD deposit shall not attract any interest.

### **3. General Terms & Conditions:**

1. The bidders may inspect the SCHOOL BUSES/ TATA SUMO on the above mentioned dates and satisfy themselves about the SCHOOL BUSES/ TATA SUMO they are bidding for.
2. Bid letter in sealed envelope should be addressed to Principal, Sanskriti School, Chanakyapuri, New Delhi.
3. The bid must reach Principal, Sanskriti School, Chanakyapuri, New Delhi on or before the due date. Tenders received after due date and stipulated time due to any reason whatsoever including postal delays shall not be considered.
4. The bid should be quoted both in figures and words including all applicable statutory taxes/levies if any. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the tenderer.
5. School reserves the right to reject bids without assigning any reason whatsoever.
6. Bid should be signed by the bidder(s). Incomplete and unsigned bids shall be rejected.
7. Bids without EMD shall be rejected.
8. The SCHOOL BUSES/ TATA SUMO shall be sold to the highest bidder on the basis of amount quoted in the bid.
9. The SCHOOL BUS/ TATA SUMO, once disposed to the successful bidder, shall not be taken back by SCHOOL, on any conditions whatsoever.
10. The successful bidder has to make full balance payment in the form of Demand Draft / Pay Order in Favour of SANSKRITI SCHOOL, within 2 days after confirmation, failing which the offer will be cancelled and EMD shall stand forfeited.
11. The successful bidder shall be required to lift the SCHOOL BUSES/ TATA SUMO from the disposal site to his premises within 5 days after the payment of the balance amount. On failure to do so, School shall have the right to forfeit the entire amount of the bidder.
12. The bidder should submit application to the concerned Transport Authority in the prescribed form for transfer/condemnation of vehicle(s) in his favour and submit a copy of acknowledgement to School before lifting the SCHOOL BUSES/ TATA SUMO from the School premises.
