Subject: Grant of recognition to the Sanskriti School Chanakyapuri, New Delhi with effect from the academic year 2000-2001 from K.G. Class to Class XII (without aid).

Madam,

With reference to your application on the subject cited above, I am directed to convey the grant of recognition to your school from K.G. class to class XII (without aid) from the academic session 2000-2001 under rule 52 of E.S.E.R. 1973 subject to the fulfilment of following terms and conditions within a year of the date of recognition: -

1. That the school shall abide by the provisions of Delhi School Education Act, 1973 and Rules framed there, under as well as the instructions issued by the Directorate of Education from time to time.
2. That the school shall appoint full time qualified and eligible staff as per the norms of the Department.
3. That the school equip the science lab. as per the norms of the department and suitable facilities for practical work shall be provided to the students.
4. That a proper library shall be maintained and facilities for reading room shall also be made available to the students as well as the teachers and books as per the ratio of 10 books per students shall be purchased and made available to the students.
5. That adequate sports materials shall be purchased and made available to the students immediately.
6. That the enrolment in each section shall not exceed the number of students calculated @ 10 Sq. feet of space per student in the classrooms and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education in each class.
7. That the school shall dispense with the services of unqualified and over aged staff.
8. That a fresh health certificate may be obtained from the NDMC and be submitted to concerned Education Officer for verification.
9. That the staff shall be paid full salary through crossed cheque from the date of opening of the school and the proof should be shown to this office.



10. That the copies of the appointment letters issued to the staff shall be submitted to the Education Officer for verification etc.
11. That the service record of the employees of the school shall be maintained as per the requirement of the Directorate.
12. That proper facilities for drinking water, toilets and first-aid shall be made to the satisfaction of this Department. Separate toilets for boys and girls as well as for male and female staff shall also be provided.
13. That the reserve fund shall be created in a scheduled bank with the amount equivalent to the three months salary of the staff.
14. Building Completion Certificate shall be obtained from the NDMC and be submitted to this Directorate immediately.
15. That the Management Committee shall be constituted as per the approved scheme of management.
16. That the change of land use shall be got sanctioned by the DDA.
17. That the building plan shall be got sanctioned by the NDMC.
18. That the school shall abide by all the conditions of recognition.
19. That the report about the fulfilment of the conditions of recognition and above conditions giving the extent to which each condition has been fulfilled shall be sent to the Education Officer after six months.

Before the expiry of one year counted from the date of recognition, you are required to send a report of fulfilment of all the conditions along with the evidence thereof, mentioned above. In case within a period of one year counted from the date of recognition the deficiencies are not removed, the recognition granted to the school shall lapse on the expiry of such period.


